At the General Meeting of the SACC held in Bridge of Allan on 17th June our representative for that evening, Sandy Denham, was present. On the evening there was a Membership Application from 4-Two Motorsport and he gave several comments about the unsuitability of this organisation to become members of SACC. However the application was proposed by Bruce Lyle and seconded by another person and on that basis 4-Two Motorsport had their application accepted.

After looking at the 'Rules of the Association', under Section 3 Membership, it states the following:

3.3.4 The General Meeting, having considered the application, will then vote on acceptance of the Club into membership. The application shall be decided by a majority of voting delegatesetc.



MOTORSPORT EVENT SAFETY REVIEW

I am writing on behalf of the Review Group for Motorsport Event Safety in Scotland to invite you to submit comments to the review. I attach a note of the group's membership and remit at Annex A.

The group was convened by Scottish Ministers following the tragic events at the Jim Clark Rally in the Scottish Borders, during which several spectators were injured and 3 killed. The group is reviewing safety at motorsport events in Scotland with a specific focus on spectator safety. The review covers all motorsport events including car, bike and kart events.

The review will not examine the specific circumstances of the incidents that are currently the subject of investigations, namely the death of a spectator at the Highland Snowman Rally in 2013 and two accidents, including the deaths of three spectators at the Jim Clark Rally in 2014.

At present, we are seeking views on rally events, particularly stage rally events. We would be interested in your general views and comments on safety at these events in Scotland, your views on safety as it affects spectators at these events and your comments on any particular issue that you feel the review should be aware of and should consider as part of our work. We will be considering both regulated and unregulated events. Any comments should be accompanied by a completed Annex B covering the use of personal data provided.

The review group is still in its early stages so we would like to offer you this early opportunity to comment, seeking a response by **Friday 12 September.** An initial response may be provided by this date with a fuller response to follow if you are unable to make detailed comment in this timescale.



We would be grateful for the association's views but it would also be helpful if you could circulate our letter to your member car clubs inviting any individual views to be submitted to us at any time but preferably before the end of September.

We would very much like the opportunity to meet with the Association and we will contact you to arrange this.

The remit of the group is as follows:

"The Motorsport Event Safety Review Group will examine safety, specifically spectator safety, at motorsport events in Scotland and make recommendations to improve safety for future events,"

Any initial recommendations prior to the Isle of Mull rally in October 2014 with final recommendations by the end of the year.
