Supplementary Regulations

1. Glenrothes Motor Sport Club Ltd. Will promote a Clubman status Autotest / P.C.A. on Sunday 17th February 2019 at Knockhill Racing Circuit, near Dunfermline, Fife, KY12 9TF.
2. The meeting will be held under the General Regulations of Motorsport UK Incorporating the provisions of the International Code of the FIA, these supplementary regulations and any written instructions of the promoting club may issue.
3. MSA Permit No. 110009 / 110010
4. The Clubman event is open to all fully elected members of the organising Club and also members of the following invited Clubs – Dunfermline C.C, 750MC, Stonehaven & Dist. M.C., Scottish Sporting C.C., South of Scotland C.C., 63C.C., E.U.M.S.C., Solway C.C., G.U.M.S.C., Aberdeen & District M.C., Berwick & Dist. M.C., East Ayrshire C.C., Knockhill M.S.C., and Saltire Rally Club
5. The event is open to all fully elected members of the organising Club and also members of Clubs which are affiliated to the following invited association, the Scottish Association of Motor Sports Clubs
6. All entrants must produce a valid club membership card.
7. GMSC Membership Costs £10.00 per adult, £2.00 per junior (16 or under) and may be applied for on the day.
8. The programme of the the meeting will be – Scrutineering starts at 10.00 am, and any competitor not signed on by 10.45 am, may be excluded. First car starts at 11.00 am.
9. The event will consist of 6 Classes as follows -
 1. Front wheel drive saloons up to 1400cc.
 2. Front wheel drive saloons over 1400cc.
 3. All specials and sports cars.
 4. Rear wheel drive saloons up to 1400cc.
 5. Rear wheel drive saloons oner 1400cc.
 6. Hybrid or Electric Powered Cars – **Must be Standard Production Cars**
10. All vehicles must comply with Motorsport UK Technical Regulations M 4.1 – 4.7
Drivers aged 16, or drivers aged 17 who do not hold a full RTA Licence, may compete provided
The vehicle must be defined as a 'Touring Car'
Engine Capacity must not exceed 1400 cc
Forced Induction is not permitted

11. Child Protection – If competitor is under 18, Entry Form must be countersigned by a parent or guardian. The parent or guardian, or an appointed representative must be present during the competition and must sign on the competitors signing on sheet. If a parent or guardian will not be present, a representative must be appointed, must show written authority from the parent or guardian to act as the child's representative and must countersign the competitors signing on sheet.
12. Awards will be presented as follows in the event-
1st in Class – an award providing 3 or more start in the class.
F.T.D. - an award
13. The entry list opens on receipt of these regulations and closes finally on Sunday 17th February 2019. The entry fee is £15.00

15. The maximum entry for the meeting is 60 and the minimum is 10. Should any of the above figures be reached the organisers have the right to amalgamate the classes or cancel the event. Entry will be selected by receipt. Entry fees may be refunded if cancelled 24 hours prior to the event.

17. Provisional results will be published as soon as possible after the event (B13.1B).
18. Any protests must be lodged as per O5.2.
19. Details of the 4 Tests will be available at signing on.
20. Each driver will have 3 runs at each test with the best 2 results to count.
21. Timing will be by hand held watches or electronic timing equipment – whichever is available.
22. The starting signal will be 3,2,1, GO or Lights.
23. The order of attempting test will be in class order.
24. Practising will not be allowed.
25. Competitors will be identified by numbers, which will be provided by the organisers.
26. Markings and penalties will be as printed in the appropriate section of the MSA General Regulations.
27. All other General Regulations of Motorsport UK apply as written except for the following, which are modified-
M. 6.6 Pylons may be less than 1 Metre high.

- 1.IV Any application form for a Licence which was signed by a person under the age of 18 years was countersigned by that person's parent/legal guardian/guarantor, whose full names and addresses have been given.
- 1.V I hereby agree to abide by the Motor Sport UK Child Safeguarding Policy and Guidelines and the National Sporting Code of Conduct.
- 1.VI I have read and fully understood the Procedure for Control of Drugs and Alcohol as contained in the MSA Yearbook Regulations H39,D35.1,G15.1.4 and have also fully familiarised myself with the information on the web sites referred to(www.ukad.org.uk and www.wada-ama.org) in particular the UK Anti Doping Rules which have been adopted by Motor Sport UK. Further if I am countersigning as the Parent or Guardian of a minor then in addition to the deemed consent to the testing of that minor (UKAD Code Art. 5.6.2) I hereby confirm that I give such consent for the minor concerned to be so tested.
